RIGHT TO INFORMATION



Ours is a grant-in-aid College offering co-education run by **Barshi Shikshan Prasarak Mandal's**, Barshi, registered under Societies Registration Act XXI of 1860 of Government of Maharashtra. The affairs of the College are governed by the Governing Council of S.B.Z.Mahavidyalaya and Barshi Shikshan Prasarak Mandal, Barshi.

The College comes under grant-in-aid Self Financing category, Therefore. 
